#### Description

The Philippine Reclamation Authority (PRA), through the Corporate Operating Budget (COB) for CY 2020 intends to apply the sum of PHILIPPINE PESOS: NINE MILLION ONE HUNDRED THREE THOUSAND FIFTY-SIX AND 31/100 (Php9,103,056.31), VAT inclusive, being the Approved Budget for the Contract (ABC) to payments under the contract for Road Repair Works Along President Diosdado Macapagal Boulevard (PDMB), Asean Avenue and J.W. Diokno (Bay) Boulevard (PBINFRA-20-001). Bids received in excess of the ABC shall be automatically rejected at bid opening.

The PRA now invites bids for the above Procurement Project. Completion of the Works is required within SIXTY calendar days (60 c.d.) from the receipt of Notice to Proceed. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or corporations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.
